- After September 7 you must pay a \$50 late penalty. You are not guaranteed a place unless we have room in that division. The \$50 late fee must be included in your first payment.
- \$20 charge for all NSF cheques.

FUNDRAISING

Each player registered with CMHA is required to pay a **\$200.00** fundraising deposit. Each season there is a need to raise additional funds to cover costs such as ice fee increases and for program enhancements. These enhancements include: Training for coaches, hockey development, participation in Provincial Championships, jersey and equipment replacement and unexpected or unforeseen costs that arise.

At the beginning of the 2010/2011 season you will be notified of fundraising events that you will have the option to participate in. You are not obligated to participate in the CMHA fundraising if you are opting to pay the fundraising fee.

Your fundraising deposit must be paid at the time of registration. CMHA will refund this deposit if you volunteer to work at any fundraising initiative for the association that is equal to or greater than the fundraising deposit.

CONDUCT MANAGEMENT PLAN

Part of the mandate of CMHA Executive is to establish a conduct management guideline for all participants in the hockey program.

Over the past several years it has become increasingly apparent that participating in the Game, whether as a player, coach, official, spectator, or administrator has become less and less enjoyable. People are leaving the game for the wrong reasons. Unacceptable conduct by coaches, players, officials and spectators is increasing both on and off the ice. It is apparent that CMHA needs to establish a clear and concise Conduct Management Program for all members of the association. With this program CMHA wants to address the fundamental values of the game:

- Shared Respect for all participants of the game
- Development of the players involved in the game
- Fun while participating in the game

Players and **both** parents/guardians (if both parents/guardians are involved with their child's hockey) must read the Code of Conduct for players and parents and sign the Code of Conduct Signature Form. The signed form needs to be turned in to the Head Coach or Manager of the team **prior to October 15th, 2010**. You must sign and hand in this form in order for your child to play.

REGISTRATION NOTES

*All players must have a copy of their birth certificate on file with CMHA before they are allowed on the ice for their first practice.

1. If you are registering for the **FIRST TIME** to play hockey with the Crossfield Minor Hockey Association you will require the following documentation:
 - Completed Registration Form (available @ www.crossfieldmha.com)
 - Copy of Birth Certificate
 - Registration Fee Payment
 - Fundraising Deposit
2. If you are moving in from another association to play in the Crossfield Minor Hockey Association you will require the following documentation:
 - Completed Registration Form (available @ www.crossfieldmha.com)
 - Copy of Birth Certificate
 - Signed Parent declaration for new residents (available @ www.hockey-alberta.ca) or a player release from the last association you were registered with.
 - Registration Fee Payment.
 - Fundraising Deposit

3. Make cheques, bank drafts, or money orders payable to "CMHA". Please do not send cash in the mail.
4. If a registered player withdraws from the program for any reason after the registration process is complete, the refund amount will be calculated as follows:
 - Administration Fee withheld for all withdraws - \$50
 - If a player drops out anytime before first skate in their division, defined as 3rd week of October, they will get back all but the \$50 withdraw fee.
 - Anytime after that date the \$50 will be taken off and the season will be prorated on how long he/she has participated.
 - Any season ending injury, the \$50 can be waived with a doctor's note.
 - No withdrawals taken after January 1st.
5. Registration fees are for day to day operation of our association. Individual teams also require operating budgets. These fees are not included in your CMHA registration. At the beginning of the year, your team Manager should develop a budget that may include, but is not limited to, tournament fees, travel costs (bus), team meals, team socks, Christmas party, end of year party, team apparel, etc...
